Indicating the Relevant Reference in the Text

- A number in superscript format, placed in the text of the essay, indicates the relevant reference.
- The superscript number appears outside the punctuation if the citation applies to a whole sentence or clause. If an author's name is mentioned in the text, place the citation number in a logical place within the sentence as close as possible to the author's name.
- Citations are numbered consecutively in the order in which they appear in the text and each citation corresponds to a numbered reference containing publication information about the source cited in the reference list at the end of the publication, essay or assignment.
- Once a source has been cited, the same number is used in all subsequent references.

- No distinction is made between print and electronic references when citing within the text.
- Here are some examples of this kind of referencing:

The largest lesion in the first study was 10 cm.¹³
 The theory was first put forward in 1987.¹
 Scholtz² has argued that...
 Several recent studies^{3,4,15,16} have suggested that...
 For example, see⁷.

Citing More Than One Reference at a Time

When citing more than one source at a time, list the numbers in ascending order and separate them by commas without spaces. If they are part of a consecutive series, use a hyphen to indicate a range of three or more:

The largest lesion in the first study was 10 cm.^{1,3,5}
 The theory was first put forward in 1987.¹⁻⁵
 The theory was first put forward in 1987.^{2-5,9,13}

CHICAGO STYLE REFERENCE SYSTEM

Chicago-style source citations come in two varieties:

(1) author-date: The author-date system is more common in the sciences and social sciences.

(2) notes and bibliography : The notes and bibliography system is preferred by many working in the humanities—including literature, history, and the arts.

Author-date style

Journal article

In the reference list, include the page range for the whole article. In the text, cite specific page numbers. For articles consulted online, include a URL or the name of the database in the reference list entry. Many journal articles list a DOI (Digital Object Identifier). A DOI forms a permanent URL that begins <https://doi.org/>. This URL is preferable to the URL that appears in your browser's address bar.

If there are four or more authors, list up to ten in the reference list; in the text, list only the first, followed by *et al.* ("and others"). For more than ten authors (not shown here), list the first seven in the reference list, followed by *et al.*

E-book

For books consulted online, include a URL or the name of the database in the reference list entry. For other types of e-books, name the format. If no fixed page numbers are available, cite a section title or a chapter or other number in the text, if any (or simply omit).

Notes and Bibliography

Journal article

In a note, cite specific page numbers. In the bibliography, include the page range for the whole article. For articles consulted online, include a URL or the name of the database. Many journal articles list a DOI (Digital Object Identifier). A DOI forms a permanent URL that begins <https://doi.org/>. This URL is preferable to the URL that appears in your browser's address bar.
