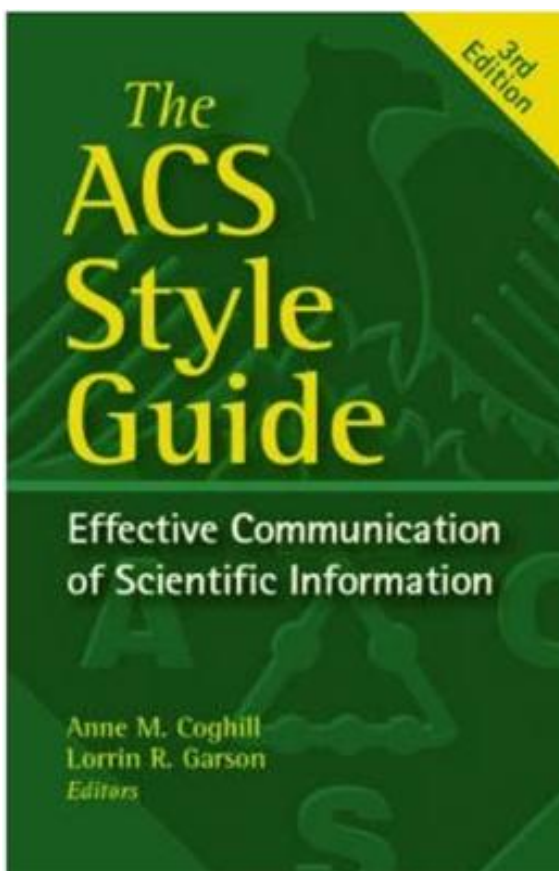


AMERICAN CHEMICAL SOCIETY (ACS) CITATION GUIDELINES.

ACS offers three approaches to cite sources in-text: **Superscript**, **Italic Numbers in Parentheses**, and **Author-Date**.

Superscript and **Italic Numbers in Parentheses** are the generally preferred methods because they distract less from the paper's content and consume less space on the page.

Author-Date is used when the year the article was published is important, such as in a literature review.

In the ACS (**American Chemical Society**) style, when using **superscript numbers** for in-text citations (e.g., ¹, ², ³), the references at the end of the document are organized **numerically**, corresponding to the order of their first appearance in the text.

In-Text Citations:

- Use superscript numbers for in-text citations without parentheses or brackets.

Example:

The reaction was studied extensively.¹ Later experiments confirmed these findings.^{2,3}

The largest lesion in the first study was 10 cm.¹³

The theory was first put forward in 1987.¹

Scholtz² has argued that...

Several recent studies^{3,4,15,16} have suggested that...

For example, see⁷.

Reference List Format:

- List the references in **numerical order**, matching the order of their superscript appearance in the text.
- Each reference starts with its **number (not superscripted)**, followed by a period.
- Format the references according to the ACS guidelines for the specific source type (e.g., journal articles, books).

In the ACS (**American Chemical Society**) style, when using **italic numbers in parentheses** for in-text citations, the references at the end of the document are listed **numerically in the order of their first citation** in the text.

In-Text Citations:

- Cite references with **italicized numbers in parentheses**, e.g., (1), (2), etc.

Reference List Format:

- The reference list is **numbered** according to the order of appearance in the text.
- Each entry starts with the corresponding number (not italicized) followed by a period.
- Use the appropriate ACS citation format for the source type (journal article, book, website, etc.).

Example of In-Text Citations:

The reaction was studied extensively (1). Later experiments confirmed these findings (2, 3).

In the **ACS (American Chemical Society) style**, if you use the **author-date citation format** in the text (e.g., *Smith, 2023*), the references at the end of the document are presented in **alphabetical order by the authors' last names**. Here's how to format them:

In-Text Citations:

- Use the **author's last name and the year** in parentheses.

Example: The reaction was studied extensively (Smith, 2023). Later experiments confirmed these findings (Doe, 2022; Brown and Green, 2021).

Reference List Format:

- Arrange the references **alphabetically by author's last name**.
- If multiple works by the same author are cited, list them **chronologically**.
- Follow the standard ACS format for each type of source (journal articles, books, etc.).

Example of Reference List:

For **Author-Date**, always use a hanging indent and organize the references alphabetically by author. For example:

Same First Author, Multiple Sources

If the author of a paper is first author of multiple sources, list single-author works first, then two-author works, then multiple-author works. Within the groups of same-first-author works cited (e.g., single, dual, multiple), list the works chronologically. Add a lowercase letter for identification if the works cited were published in the same year.

For example:

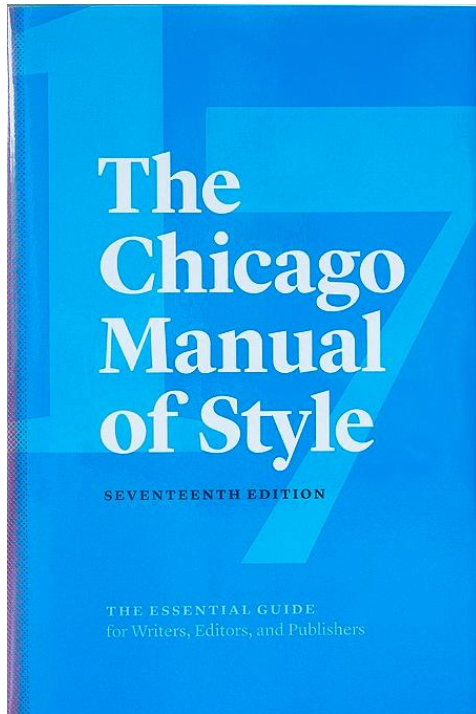

CHICAGO-STYLE REFERENCE SYSTEM

Chicago-style source citations come in two varieties:

Author-date: The author-date system is more common in the sciences and social sciences.

Notes and bibliography: The notes and bibliography system is preferred by many working in the humanities—including literature, history, and the arts.

In the reference list, include the page range for the whole article. In the text, cite specific page numbers. For articles consulted online, include a URL or the name of the database in the reference list entry. Many journal articles list a DOI (Digital Object Identifier). A DOI forms a permanent URL that begins <https://doi.org/>.

In-Text Citations:

Include the author's last name, the year of publication, and a page number or other locator may be added, following a comma. Example: Scholars argue this concept is significant (Smith 2020, 45).

Reference List Format:

- Arrange the references **alphabetically by author's last name**.
- Include the author's last name coma first name and initial (if any)
- If multiple works by the same author are cited, list them **chronologically**.
- Follow the standard Chicago format for each type of source (journal articles, books, etc.).

Example of Reference List: Always use a hanging indent and organize the references alphabetically by author. For example:

Notes and bibliography

This system uses footnotes or endnotes for in-text citations and a bibliography at the end.

Each time a source is used in the text, it must be cited by note: footnote or endnote.

- Footnotes appear at the foot (bottom) of the page and are preferred.
- Endnotes appear at the end of the paper before the bibliography.

(Endnotes are useful when footnotes have become exorbitant.)

- Include a superscript number at the end of the sentence.
Example: Scholars argue that this concept is significant.¹
- In the footnote or endnote:
¹ Author's First and Last Name, *Title of the Book* (Place of Publication: Publisher, Year), Page Number.
Example:
¹ John Smith, *Understanding History* (New York: Oxford University Press, 2020), 45.

Use a shortened version:

Journal article

In a note, cite specific page numbers. In the bibliography, include the page range for the whole article. For articles consulted online, include a URL or the name of the database. Many journal articles list a DOI (Digital Object Identifier). A DOI forms a permanent URL that begins <https://doi.org/>. This URL is preferable to the URL that appears in your browser's address bar.

EXAMPLE TEXT

It should be clear which ideas are yours and which belong to someone else.¹ Including sources in your text should be done “through quotation, paraphrasing, summarising, analysis, interpretation, discussion and evaluation of sources.”²

When citing sources in your text, “make sure they are placed where they belong.”³ The footnote number should be placed at the end of a sentence or phrase, after a quotation.

A reference list provides the full details of sources at the end of your assignment.⁴ Every source cited should be in your reference list, and vice versa.⁵

A referencing style is a set of formatting rules for citations and reference lists.⁶
